a. Chairperson's Report

Fred attended a meeting in Cupar with Yan Coal about a potash mine somewhere between Southey and Raymore. Check out www.yancoal.ca. This is Phase I of their assessment. Golder Associates is their environmental consultant. The water needed (0.2-0.6 cubic metres per second) is likely coming from Buffalo Pound Lake. Production is estimated at 2.8 Million tons per year. Belle Plaine uses 30 acre feet per month [my calculation is that is equivalent to 0.015 cubic metres per second][Surface area of Buffalo Pound Lake is 29.5 sq. km]

b. General Manager's Report

Provincial Association of Resort Communities of Saskatchewan is working on a report of what the status of the resort community water & wastewater is at this time. Gary Dixon will assess as to whether we can get a copy of the report.

There was some concern that the pressure be put such that if the action can be completed before the conclusion date, that that was a better resolution of the plan.
